## MEMORY LAB SERVICE AGREEMENT AND LIABILITY RELEASE

**Services:** Lane Libraries Community Technology Center (hereinafter "Lane Libraries") shall provide access to the Memory Lab digital conversion station (the "Memory Lab") to library patrons for their use. Lane Libraries shall not be required to provide technical assistance or supervision besides general directions regarding the use of the Memory Lab. Lane Libraries reserves the right to cease any and all services provided in the Memory Lab at any time without notice. Furthermore, Lane Libraries may, in its sole discretion, revoke your access to the Memory Lab at any time without notice.

**Representations and Warranties:** LANE LIBRARIES MAKES NO REPRESENTATIONS OR WARRANTIES REGARDING THE OPERATION, FUNCTION, AND ALL MEMORY LAB EQUIPMENT IS BEING PROVIDED 'AS IS', 'AS AVAILABLE', AND 'WITH ALL FAULTS' FOR LANE LIBRARIES PATRON USE. FOR THE AVOIDANCE OF DOUBT, LANE LIBRARIES HEREBY DISCLAIMS TO THE FULLEST EXTENT PERMITTED BY LAW ANY AND ALL REPRESENTATIONS AND WARRANTIES WHETHER EXPRESS OR IMPLIED, STATUTORY OR OTHERWISE, INCLUDING BUT NOT LIMITED IMPLIED WARRANTIES OF MERCHANTABILITY, TITLE, SATISFACTORY QUALITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT. WE MAKE NO REPRESENTATION OR WARRANTY THAT YOUR ACTIVITIES OR USE OF THE MEMORY LAB IS LAWFUL OR THAT MEMORY LAB SHALL BE AVAILABLE AT ALL TIMES OR BE FREE OF ERROR. YOU ASSUME ALL RISK, AND FOREVER RELEASE AND DISCHARGE LANE LIBRARIES FROM ANY AND ALL LIABILITY, FOR ANY PHYSICAL DAMAGE TO YOUR VIDEO HOME SYSTEM ("VHS"), 8MM FILM, RECORDS OR LOSS OF DATA OR CONTENT CONTAINED ON THE VHS THAT RESULTS FROM THE USE OF MEMORY LAB.

There may be times when the Memory Lab is not available for technical or maintenance related reasons, whether on a scheduled or an unscheduled basis.

Limitation of Liability: To the fullest extent permitted by applicable law, Lane Libraries disclaims and will not be liable for any damages (including, without limitation, direct, indirect, punitive, special, incidental, consequential and/or exemplary damage (including, without limitation, bodily harm, emotional distress, loss of business, revenue, profits, goodwill, or other economic advantage) arising out of or in connection with your use of the Memory lab or any other Lane Libraries services associated with the Memory Lab including, without limitation, the loss, corruption, or alteration of media or digital files (including formats such as 8mm film, records, VHS tapes, etc.) (collectively "Media") that may occur during or after your use of the Memory lab.

Indemnification: You agree to indemnify, release, defend and hold harmless Lane Libraries and its affiliates, officers, agents, directors, employees, representatives, or associates from any and all losses, liabilities, expenses, damages, costs (including reasonable attorneys' fees and court costs), claims, and/or action of any kind whatsoever arising or resulting from your use of the Memory Lab, your violation of this agreement, any state or federal regulations or laws or violation of any copyright laws.

**User Certification:** You certify that you either own or have secured all necessary permissions and rights to use the Media submitted for digitization via the Memory Lab. You acknowledge that you shall indemnify Lane Libraries for any violation of any copyright laws due to your use of the Media and its digitization with the Memory Lab.

**Digital Files Handling and Backup:** Upon digitization, the digital files are accessible only temporarily as part of the digitization process, and Lane Libraries does not store these files indefinitely or provide backup services. Upon the completion of the conversion process you shall be solely responsible for immediately transferring and backing up all digitized files to your own devices and portable media. For the avoidance of doubt, digitized files may no longer be accessible after you leave the Memory Lab, and all transfers shall be completed in the same session.

**Internet Use Policy Compliance:** All patrons further agree that all Media submitted for digitization will comply with the Lane Libraries' Internet Use Policy. You further acknowledge that the display of sexually explicit imagery or other graphic content deemed disturbing, offensive, or hostile to others is strictly prohibited. Furthermore, it is the parent or legal guardian's responsibility to restrict a minor's access to such content.

**Governing Law:** This agreement shall be governed by, and construed in accordance with, the laws of the State of Ohio without regard to any conflict of law principles. The parties hereto agree to exclusively submit to the jurisdiction of the courts in Butler County, Ohio.

**Miscellaneous:** If any clause or provision in this agreement is found to be invalid by any authority having competent jurisdiction, the invalidity of such clause or provision shall not affect the validity of the remaining clauses or provisions contained herein. This agreement constitutes the entire agreement between you and Lane Libraries relating to this subject matter and supersedes all prior agreements, undertakings, representations, warranties, and arrangements of any nature relating to the same.
